An overview was provided of their review of the initial January meeting notes. Background was reviewed on work being done at the national level regarding supervision and classification of plants to create risk models that make sense to industry and to assist in clarifying for owners what supervision requirements are.

The top 3 priorities of the working group are:

- Clarification of supervision, and discussions regarding a potential plant registration system
- Rules that need to be clarified
- Update and address BOMA concerns

Other than AMA and ABSA representation, there did not seem to be a fit for other stakeholder groups. It was noted that the problem of engagement of the Engineering & Procurement or EPC Consultants was a significant issue as there was no "industry" collaboration or association to draw from or which could be more generally represented. However, it was recognized that subject matter experts may be brought in when needed It was noted that members of the 2013 Division 2 working group would also be invited to work on implementation issues regarding Div. 2 and other fatigue service equipment; particularly regarding the CSA B51 requirement additions, and potential changes in the PEIM program, removal of Variance, etc.

The working group reviewed and discussed the following areas of opportunity:

- Reducing the number of designs initially refused by ABSA by giving recognition to both good/ successful organizations and the bad ones, looking at 'rewarding' the successful ones, and on continuing efforts to educate & improve industry's design registration submissions.
- Implementation of the changes to Division 2, the need to develop control measures and the variance to be removed
- Actively supporting the pending/ proposed Safety Codes Act revisions to increase the timeliness of code adoption (Ministerial vs. Cabinet actions)
- Development of a strategy for a full PESR review with focal groups prior to a full consultation
- Work with industry and AMA regarding compliance when the Fired Heater/ Gas Safety variance expires, in light of the what is believed to be incomplete stakeholder engagement

The Working Group Chair will work on the first draft of the Terms of Reference.

- Overpressure Protection
- Piping Registration

6. Appointment

The resumes of both Jacques St. Onge and Zeljko Gnjatic were circulated and reviewed and each were given due consideration. A written ballot vote was taken to determine the potential appointee and Zeljko Gnjatic received a majority of votes. Tyler Wightman performed this service and destroyed the ballots afterwards.

Marvin Kossowan / Todd Loran moved to recommend to the Coordinating Committee the appointment of Zeljko Gnjatic to the Boilers and Pressures Vessels Technical Council for a term until January 31, 2017, effectively immediately; CARRIED

7. Pressure Welders Amendment Regulation

An overview was provided on the background review of the proposed amendment regulation with the latest newly drafted regulation circulated at today's meeting.

Clarification was provided on Section 25 and how the wording provides an extension of the existing regulation (which expires at the end of May 2014) and that all other proposed changes would take effect on October 1, 2014.

A discussion was held regarding the proposed certification of Tack Welders and clarified that this would be defined in the syllabus being worked on by ABSA and AWOC. It was noted that this should be a task for the working group to propose a definition in order for the Administrator to issue an interpretation. [Roux / Kossowan]

The following corrections were made to the most current draft of the Pressure Welders Amendment Regulation:

- 3(e)(7) ... Competency <u>functions under the direction of the Welder Examiner and</u> has...
- 4(b)(k) ... requirements up to for which...
- 4(b)(l) ...requirements up to for which...

- 7 Section 10(2) and (3) are amended by striking out "prospective employer" wherever it occurs and substituting adding "and testing organization"
- 9 relative to 14.2: Track Welder corrected to read Tack Welder
- 9 relative to 14.2(b): ...steamfitter-pipefitter or journeyman structural steel and plate fitter or...

Mike Clancy / Marvin Kossowan moved to recommend to the Minister, through the Coordinating Committee, the adoption of the Pressure Welders Amendment Regulation, as corrected; and to waive the 90 day review period; CARRIED

8. Other Topics

The Chair reported that there is a training course specific to ASME Section VIII Division 2, Part 5 "Design by Analysis Requirements" being offered by Becht Engineering Canada from May 26 to 29, 2014.

AWOC noted that a one-day session will be held on welding duplex and super duplex on May 27, 2014 being hosted by the University of Alberta and the Canadian Welding Association.

It was noted that at the May 2014 meeting, discussion needs to be held regarding a number of larger sized Heritage Boilers that was missed in the regulation amendment. Notes regarding these Traction Engine issues will be circulated in advance of the meeting.

The Chair reviewed a case of the lack of availability of Valves cast from 1 ¼ Cr materials and where only 2 ¼ Cr cast valves were being manufactured today. He noted that this substitution was essentially an upgrade, but that each one was acting to trigger Piping Alteration rules and submissions to Design Survey. He questioned whether this might be a subject for a general variance to accept them; and stated that he will work with ABSA and the Administrator to ascertain if the designs of PP previously registered but with this specific change of materials might still be declared valid .

It was questioned regarding the status of the SCC web portal; and it was clarified that implementation glitches are being worked on.

The Administrator's Requirement Document with respect to the new "Reduced Supervision" provisions under the amended Power Engineers Regulation is close to being ready and will again be circulated to all council members for one final review. Graham Wilson is asked to send the document out immediately and any feedback should be provided directly to Todd Loran and Graham Wilson ASAP. The Administrator will be issuing the document as soon as possible since it is important for the industry to implement the amended regulation quickly instead of relying on the provisions of the previous version of the regulation.

The Administrator advised that the National Board Annual Meeting in conjunction with the ASME Code Committee Meeting Week would be is being held beginning May 11, 2014 at Seattle, WA, USA.

The Administrator also reported that the new edition of CSA B51 Code was published as CSA B51-14 in March, 2014.
